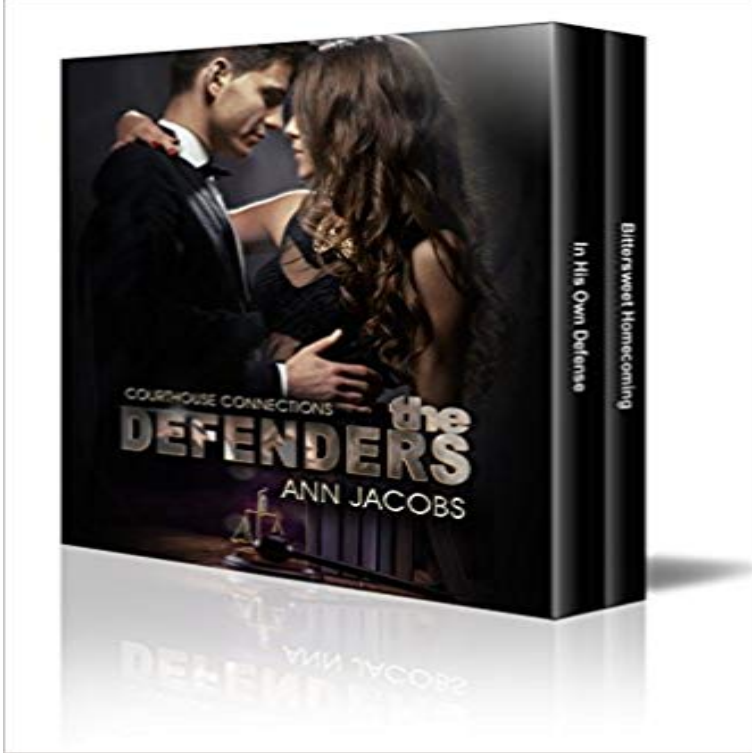


The Defenders: A Two Book Box Set (Courthouse Connections 2)
