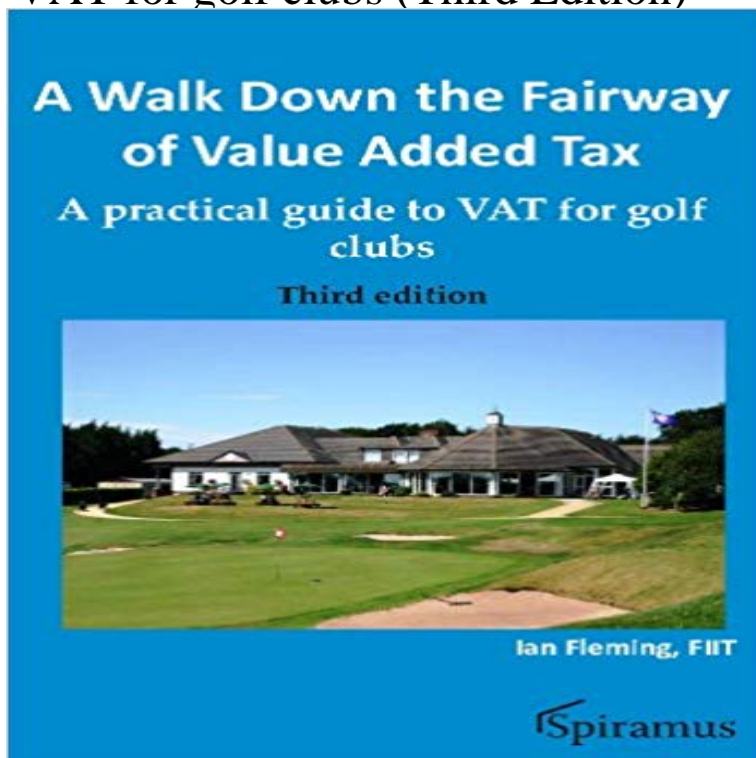


# A Walk Down the Fairway of Value Added Tax: A practical guide to VAT for golf clubs (Third Edition)
